#### What is the CPA?

The Citizen Police Academy is a 12 week program designed to open the lines of communication between the Denton Police Department and the community. It is the sincere desire of the Denton Police Department to develop a style of policing that reflects a collaborative effort between the community and police. This process requires an informed citizenry and it is the goal of the CPA to increase "Understanding through Education."

#### When are classes held?

Classes meet one evening per week for eleven weeks and are conducted at no cost to the participants.

# What Topics Are Covered?

The curriculum is intended to provide a comprehensive overview of the operational dynamics of the Denton Police Department and the critical role citizens play in our community crime control efforts. Each class is given by Police Officers who actually work every day in the job area they are presenting. For example, School Resource Officers (SRO) will discuss the SRO program and its effects on our children. Traffic Officers will discuss their role in enforcing the Traffic Laws and reducing the number of accidents in the city. Detectives will discuss the types of offenses that occur in Denton and their role in investigating those crimes. We believe that policing by partnership, the union of efforts, is essential for effective law enforcement.

#### Who Should Attend the CPA?

Any citizen who lives or works in the City of Denton is eligible to attend the Citizen Police Academy. The only exceptions are those people who are immediate family members of a Law Enforcement Officer. Each class is limited to 24 people and participants are chosen to ensure a broad community representation so everyone might develop an informed understanding of the effects that social, cultural, educational and economic institutions have on our neighborhoods.
